### 15. CE REPORT

The CE presented the following report to members.

### **Schools Directorate**

### Schools

Schools continue to operate within the updated guidance issued following the mid-term break from the Department of Education. Masks are no longer required but staff and students can do so on a personal basis. The return to normal school routines and normal teaching and learning activities was welcomed. However, we are continuing to experience staff and student absences due to Covid-19. These absences have, and continue to be, significant at times. To date, we continue to be fully operational. Schools are supporting students as they continue to adapt to returning to learning alongside preparations for the return to normal examination timetables.

- At present, some of our schools have received queries from Ukranian families who have moved to Ireland and who wish to enrol students in our schools. We will continue to support families in whatever way we can. We await further guidance from the Dept. of Education in relation to supports that will be made available in this area.
- LOETB/Laois Education Centre, Optimising Middle Leadership Webinar Series
  facilitated by Dr Joe O'Connell is continuing for school leaders holding API and APII
  positions in our schools. The second session took place on Wednesday 2 March with
  the final part of the series taking place on 26 April.
- LOETB Principals and Deputy Principals attended the Annual ETBI Principals and Deputy Principals Conference on Tuesday 8 February 2022.
- LOETB School Ethos Digital Storytelling Competition launched Wednesday 2nd
  March inviting all LOETB schools to get involved. The Digital Story should specifically
  refer to one of the ETB Core Values (Excellence in Education Care, Respect,
  Community, Equality), and how this Core Value is alive in your school. here will be a
  prize for the winner in each school and a prize for the overall LOETB Winner.
- The Take 1 Sustainability Programme Information Session took place with Valerie Lewis from ETBI on Tuesday 1 March via Teams. Our schools will be invited to participate in the ETBI-supported May Day for Sustainability (10 May 2022) to further create awareness around Sustainability.
- Digital Schools Awards is a programme for schools who undertake a SELFIE
  assessment. All LOETB schools are planning to undertake a SELFIE assessment in
  March. Schools will then have the option to register with the Digital Schools Awards
  Academy. The aim of the academy is to provide SELFIE assessed schools with digital
  education mentor supports and professional development resources around the
  themes addressed within the SELFIE self-reflection tool. The themes are Leadership,
  Collaboration and Networking, Infrastructure and Equipment, Continuous

Professional Development, Teaching and Learning, Assessment and Student Digital Competences.

- UCD Power 2 Progress Project Launch Monday 7 March 2022 Tullamore College, St Fergal's Rathdowney, Oaklands Community College, Portlaoise College, and ASCN Clara are involved in a programme run by UCD which supports students reach their academic potential through enhanced academic supports. The project launch was attended by representatives from UCD, Zurich Foundation and Rethink Ireland. The keynote speaker was Professor Paul Rouse from UCD.
- Oaklands Community College student Maeve Frances McIntyre has been awarded the Trinity College Dublin Entrance Exhibition Award as the incoming student with the highest points from their public exams.
- Clonaslee College opened a new sensory room "Narnia" for all students. Recognising
  the negative impact of Covid-19 on students through social lockdowns and school
  closures, the staff of Clonaslee College have created a space where students can be
  offered a quiet, distraction-free zone. The room was formally opened by Minister
  Josepha Madigan on Friday 11th March 2022. This was an exceptionally positive
  event emphasising the inclusive, student-centred education practice in Clonaslee
  College.

### **Youth Services:**

- DCEDIY Resilience and Effectiveness Initiative 2022: The DCEDIY allocated €17,500 to LOETB to administer under Grant Scheme 2022. The Resilience and Effectiveness Initiative is a UBU Your Place Your Space initiative to support UBU funded organisations to deliver a more efficient and comprehensive service to young people, while ensuring that they have sufficient resilience to operate effectively in the medium to long term. Information in relation to the Grant Scheme has been sent by email to all four UBU funded organisations.
- DCEDIY Local Youth Club Grant Scheme 2022: The DCEDIY allocated €82,544 to LOETB to administer under Grant Scheme for 2022. The Scheme supports voluntary youth club/groups activities for young people, with priority given to clubs/groups catering for aged of 10 and 21. The primary focus of the Scheme is to assist local, volunteer-led youth clubs/groups that provide a programme of youth work activities for young people. Information in relation to the Grant Scheme has been advertised on LOETB website, social media and local newspapers. The deadline for applications is Friday 1 April 2022.
- DCEDIY Targeted Youth Employability Support Initiative 2021-2022: The DCEDIY (in conjunction with the Minister for Rural and Community Development) allocated €30,580 to LOETB for this Grant Scheme for 2021/2022. The aim of the Targeted Youth Employability Support Initiative (TYESI) is to engage and support the harder to reach young people aged 15 to 24 years who are not currently in employment, education or training. The focus of the initiative is on soft skills and developing these in relation to employability. Youth Work Ireland Midlands/Tullamore Youth Project are the sole and successful applicant.
- DCEDIY UBU Your Place Your Space 2022: The DCEDIY has approved grant funding of €382,287 to LOETB to administer under Grant Scheme for 2022. UBU Your Place Your Space provides funding to youth services that support young people to develop the personal and social skills required to improve their life chances. This includes services covering health and wellbeing, education, employment and social connectedness. The scheme will target young people aged between 10 to 24 years who are experiencing economic, social and cultural disadvantage.

• Laois Offaly Local Creative Youth Partnership (LCYP)/Creative Youth Programme: The Department of Education through the Creative Ireland Programme has allocated €100,000 to Laois Offaly Local Creative Youth Partnership (LOETB) to administer under Grant Scheme for 2022. The Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media (TCAGSM) through the Creative Ireland Programme the LCYP was approved grant funding of €30,000 to Laois Offaly Local Creative Youth Partnership (LOETB) to administer under Grant Scheme for 2022 (downfall of €20,000 from 2021). Minister for Department of TCAGSM Catherine Martin TD announced on the 8th of February that the Creative Ireland Programme is being extended to 2027. Laois Offaly LCYP, actively support creative youth providers and practitioners who work directly with young people considered hard to reach/seldom heard aged 10-24 years in out of school setting. Youth voice and participation lead the creative activities identified. Core and central to the work of the LO LCYP is youth voice.

Currently working with: Young Traveller Men Tullamore, LGBTI+ Music Group Tullamore, ongoing Afterschool of Music Programme in partnership with Music Generation in five schools across Laois and Offaly, Down Syndrome Laois and Offaly branches and Down Syndrome Midlands, Laois and Offaly Families for Autism, Introduction to virtual reality.

### **Music Generation:**

- Music Generation Laois and Laois School of Music have successfully secured €24,200 for the Laois-Franklin Youth Project from Laois County Council under the LPSS 2022. Nine young musicians and their adult leaders from Franklin, Tennessee, will come to Portlaoise from the 16-23 June 2022 and these funds will be used to host a Gala concert, and develop joint repertoire.
- Eleven young traditional musicians from MG Laois took part in Donal Lunny's Atlantic Arc in Carlow on 4-6 February.
- Two recent concerts programmed included the Laois School of Music Beginner
  Orchestra concert in the Dunamaise Arts Centre on Sunday 13 February, and 're:

  February.
- Saturday 12 March, Laois Music Centre, Church Ave, Portlaoise, Album launch: Uilleann Piping from County Kildare Joe Byrne, The Ace and Deuce of Piping Volume 5. The fifth CD in Na Piobairí Uilleann's Ace and Deuce of Piping series is a solo recording by Joe Byrne on concert pitch pipes made by Paddy Hyland. Joe Byrne is from Athy in Kildare and joined Music Generation Laois in 2012, studying pipes with Gay McKeon in Portlaoise, part of our partnership pipe programme with Na Piobairí Uilleann. Joe now teaches the pipes for Music Generation Laois, as well as Music Generation Louth and Music Generation Offaly-Westmeath. Paddy Hyland is a

# **FET Directorate**

LOETB/SOLAS Strategic Dialogue and Performance Agreement
The LOETB CE & FET Management team (FMT) met a SOLAS delegation in Mount Lucas on
Thursday 3 March. The meeting focused on LOETBs FET provision to date and the next
Strategic Performance Agreement.

The discussion was guided by LOETBs focus on Green Skills, NZEB, Retrofit, and the FET Centre provision model. The next stage of the process will be an agreement on targets in the following areas:

- Progression to HE
- Progression to Employment
- Certification at Levels 1-3
- Green Skills provision
- Skills To Advance (Employer/Employee focused provision)

# National Construction Training Centre, Mount Lucas

Under the new FET Capital Call process, LOETB has requested permission to expand provision at Mount Lucas. This expansion will incorporate a 10,000 sq. ft. unit to double our NZEB/Retrofit provision and a second 15,000 sq. ft. unit to house provision targeted at the Modern Methods of Construction (these include site simulation, BIM, Digital Twins and future Construction modelling).

This application has been made under the 'Strategic Infrastructure Upgrade Fund' and has the support of CIF, SOLAS, DFHERIS, and will contribute significantly to ensuring the FET sector meet the national strategic targets.

# **Programme Development**

LOETB and TUS (Limerick) have co-developed a Special Purpose Award at Level 6 in Green Skills. This 'Retrofit Co-ordinator' award is targeted at industry professional (e.g., architects, quantity surveyors) and focuses on the oversight of Retrofit installation. This role was outlined in the Skills for Zero Carbon report, 2021 and will be co-delivered by LOETB and TUS staff.

This collaborative FET/HE programme development process is one of the first in the country and provides LOETB with a far greater ability to respond quickly and effectively to industry needs.

# **FET Guidance Strategy**

LOETB FET Services have a developed a single, fully integrated guidance service. This service will ensure that all FET learners have access to guidance and support during their time with LOETB.

Our strategy will contribute significantly to our Pathways model, supporting learners to identify their progression goals. The strategy will be managed by our two Guidance coordinators based in our Learner Information hubs in Tullamore and Portlaoise. This strategy is outcomes focused and measurable and will be reviewed annually by the FMT.

# LOETB FET Beneficiary Report 2022

LOETB provides a fully integrated FET service across the region. This provision is delivered in ten FET Centres, two Prison Education Units, the Birr Outdoor Education and Training Centre, the Midlands Skills Centre, the National Construction Centre at Mount Lucas, and collaboratively in second provider centres in Tullamore and Portlaoise.

These centres deliver a range of full and part time programmes, across all NFQ levels with learner supports available on-site. These centres are supported by two Learner Information Hubs in Tullamore and Portlaoise which provide 'one-stop-shop' guidance and recruitment services to past, existing and future FET learners.

This approach is informed by the recent SOLAS strategy document; Future FET: Transforming Learning 2021-25.

The nature of provision in these centres is aligned to the identified regional growth sectors using relevant reports from the Expert Group on Future Skills Needs, the Strategic Labour Market Research Unit (SLMRU) in SOLAS and local and regional employer engagement undertaken by LOETBs Enterprise Support Team. This provision is agreed and underpinned by the annual Strategic Dialogue process and LOETBs Strategic Performance Agreement with SOLAS.

As a result of this approach, LOETB provided for 12,088 FET beneficiaries in 2021, which equates to 98% of the 2019 pre-pandemic total.

Furthermore, this figure represents increases in the following areas:

- 'Access' Progression (community-based to FET Centre) increased from 47% (2019) to 54%
- Progression to FET and/or HE increased from 62% (2019) to 69%
- Progression to Employment increased from 17% (2019) to 27%
- Retention across the FET scheme increased from 81% (2019) to 86%

# LOETB supporting Community and Voluntary providers

A number of Community and Voluntary providers in the region are currently trying to reengage with QQI. The new process, based on QQI's policy, is proving to be extremely difficult for smaller providers.

To support these providers, LOETB has developed a Memorandum of Understanding (MOU) allowing these providers to work within LOETB's QA management system. This will ensure that these providers can continue to work within their communities and are supported to deliver high quality QQI accredited courses and programmes.
