13. CHIEF EXECUTIVE'S REPORT

Schools Directorate

Schools:

- Congratulations to all students who received their Junior Certificate Results on 23 November.
- Offaly Schools' County Sports Day hosted by Ard Scoil Chiaráin Naofa took place at the Harriers, Tullamore on Thursday 13 October 2022.
- SELFIE Masterclass On 4 October Dr. Caroline Pulfrey of the EPFL Institute in Lausanne, Switzerland, facilitated an online webinar for school digital leaders on best practice in school digital planning. This webinar was held as part of our support programme for schools in developing a school digital learning plan based on their SELFIE survey results and to support the implementation of the Digital Strategy for Schools. All LOETB schools have completed the SELFIE survey.
- Hackathon -LOETB Schools' Support recently hosted the first ever Irish SELFIE 'Hackathon' at Laois Education Centre. The event, based on a model designed by the European Commission, saw students and teachers gather from LOETB schools to work collaboratively on developing initiatives to improve the use of digital technologies in their schools. The day culminated with the students successfully presenting their ideas to the group, as well as an online audience of European experts in digital technology in Education. The event was a key part of LOETB schools' efforts to be recognised with a European Digital Schools Award a process that will conclude next April when the judges examine the digital progress of the respective schools.
- COPILOT -Representatives from LOETB schools recently attended a partner meeting in Veria, Greece as part of the ERASMUS CoPILOT programme. The meeting allowed LOETB teachers to visit several educational institutions in Greece, with the aim of identifying approaches and digital methodologies that could be used to support teachers and school leaders with digital transformation in their own schools. The trip was a significant success, with teachers returning with new initiatives planned for their schools; while there was agreement on a number of further partnerships and projects between the different CoPILOT partners (LOETB, UCD, IES Cristobal de Monroy and Akadimos.)
- PEDL for Parents The Programme to Enhance Digital Literacy (PEDL) is underway
 in Ard Scoil Chiaráin Naofa Clara, Portlaoise College and Banagher College. PEDL is a
 five-week experiential programme aimed to foster the development of parents' digital
 skills so they can support their children with digital learning.
- PEDL Erasmus exchange took place from 2-6 October to Liceul Technologic Iorgu
 Varnav in Suceava, Romania PEDL has also been granted funding under the Erasmus+
 programme. Two representatives from LOETB attended an exchange to Romania to
 observe practices undertaken by schools to engage parents.

- ICERI Conference school leaders from two LOETB schools and a member of the Schools' Support team attended the International Conference on Educational Research and Innovation in Seville from the 7-9 of November. Attendance at the conference was made possible by the Learning Links for Leaders Erasmus+ project. In addition, the LOETB team made a school visit to IES Cristobal de Monroy in Seville to observe educational practices.
- ETB Ethos and Core Values The second Community of Practice meeting took place on 16 November. ETB Schhools' Patrons Framework was officially launched on Wednesday 23 November in Kilashee House in Naas. Ard Scoil Chiaráin Naofa Clara and Dunamase College are participating in School Self Evaluation Pilot with DCU and ETBI.
- First Lego League Ard Scoil Chiaráin Naofa Clara, St. Fergal's Rathdowney, Oaklands Community College are participating in Lego League with UCD. Tullamore College are a member of the league with Laois Education Centre
- Webinars LOETB Schools' Support and WWETB are jointly hosting two webinars in November on teaching, learning and assessment. Tuesday 22 November focuses on Canva and SELFIE for teachers and Monday 28 November focuses on inclusive classroom practice.
- Provision Mapping Pilot Project with Mary Immaculate College (MIC) Clonaslee College and Tullamore College continue to participate in provision mapping pilot led by Dr. Johanna Fitzgerald of MIC. All SENCOs also invited to attend training with MIC.

Youth Services:

- Youth Work Plan: Youth Services are currently working on the development of a Youth
 Work Plan for Laois and Offaly. The Youth Work Plan sets out legislative basis and policy
 context of youth service provision, underpinned by a detailed socio-economic profile
 LOETB region. Key Stakeholder consultations are now complete and Focus Group
 consultations with Young People are taking place. A survey with a wider group of Young
 People is delayed and will now place in December 2022.
- DCEDIY Local Youth Club Grant Scheme 2022: The DCEDIY allocated €82,544 to LOETB to administer under Grant Scheme for 2022.
- DCEDIY Youth Capital Funding Scheme 2022 for Youth Services and Clubs/Groups: The DCEDIY allocated €33,783 to LOETB to administer under Grant Scheme 2022.
- Minor Grant Scheme for Youth Services and Youth Clubs 2022. The DCEDIY allocated €25,589 to LOETB to administer under Grant Scheme for 2022.

Laois Offaly Local Creative Youth Partnership

- The Creative Ireland Programme has a partnership with Trinity College Dublin to conduct a systematic analysis of outcomes and trends in Phase One of the Creative Youth Plan (2017-2022). LO LCYP will take part in this process in November.
- Youth Advisory Group (YAG) -Under the guidance of Hub na nÓg, in November the LO LCYP will support 2 young people take an active role in the Youth Advisory Group. The purpose of the (YAG) is to collaborate on the creation of a youth friendly infographic to communicate the new Creative Youth Strategy 2023-27.
- World Down Syndrome Month In October, the LCYP supported Offaly Down Syndrome to put on A photographic exhibition portraying members as who they really are. The exhibition toured Co. Offaly libraries for the month of October Down Syndrome Awareness Month.
- **Ferbane will take part in a community project** in African Drumming Ireland, with 95 young people involved. They are also part of the development of a sensory garden seating area in a large housing estate in Gallen View Ferbane. This is a community arts project with Gallen Foroige taking place October November.

10 Traveller boys from Laois Traveller Action Group in November-December will
undergo a taster programme. The programme will be an introduction to engineering,
making, soldering, as requested by the Traveller boys with the hope it can be developed
further next year and the introduction of STEAM programmes.

Music Generation:

- Official Opening of Laois Music Centre, 21 October 2022: Cathaoirleach of Laois County Council, Cllr. Thomasina Connell, officially opened the newly renovated Laois Music Centre on Friday 21 October. The opening event included performances from musician educators and young musicians from Laois School of Music and Music Generation Laois. This event was supported by the Live Performance Support Scheme via Laois County Council and the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. Laois County Council purchased Laois Music Centre (formerly Scoil Mhuire) in 2018 as a permanent home for both Music Generation Laois (MGL) and Laois School of Music (LSM) under the Urban Regeneration and Development Scheme.
- Laois School of Music Birthday Celebrations, 22 and 23 October: Laois School
 of Music celebrates 21 years in 2022. Two concerts took place in St Peter's COI, Portlaoise
 to mark the milestone, on the 22 and 23 October, featuring alumni, current students and
 Musician Educators. These concerts were supported by the Live Performance Support
 Scheme via Laois County Council and the Department of Tourism, Culture, Arts,
 Gaeltacht, Sport and Media.
- Tionól Harp + Pipes 2022: Over 100 young harpers and pipers, along with their
 Musician Educators, descended on Portlaoise from the 4-6 November for the annual
 Music Generation Laois Tionól. This residential weekend, now in its seventh year,
 included workshops and concerts, and the premiere of a new suite of music by Áine
 McGeeney, performed by the Music Generation Laois Trad Orchestra. Tionól is supported
 by the Music Generation/Arts Council Partnership Creativity and Collaboration Fund.
- Children's Song Project: Music Generation Laois launched a Children's Song Project on Tuesday 8 November. This project will work with primary school children from Cloneyhurke NS, Rath NS and Paddock NS to compose a series of original songs supported by Creative Ireland Laois, Laois County Council, and the Art Council's Young People, Commissions and Education Award. Children and teachers from Cloneyhurke, Rath and Paddock National Schools will take part in creative workshops with Composers Sarah Murphy and Lorna McLaughlin alongside Music Generation Laois' Nuala Kelly, to develop a new suite of songs for County Laois. The project will culminate with a large-scale performance of the newly written songs in June 2023. The newly composed songs will then be disseminated as a resource for schools across Laois, through Laois Education Centre (LEC), to engage lots more children in this special music project.

FET Directorate

Provision at NCTC, Mount Lucas in 2022

Mount Lucas has provided NZEB & Retrofit to over 1000 learners this year on the following courses:

The cohort of learners range from certified training courses for companies (Kingspan/Extratherm/Chadwicks/Energlaze/Brooks BAM/SISK etc.) to training for County council officers (Laois/Offaly/Kildare/Louth)

The External Wall Insulation Installer (EWI) course and the newly launched Air Tightness and Vapour Control (AVC) go for QQI accreditation in February 2023 as Level 5 Special Purpose Awards. 2023 will also see the roll out of the LOETB Transition Year NZEB programme

Adult Literacy for Life Strategy

The Adult Literacy Team has been expanded in line with the Adult Literacy for Life (ALL) 10-year strategy which was launched by Minister Simon Harris on 8 September 2021.

This ambitious strategy makes a number of commitments including:

- Increasing the number of learners engaging with literacy and language support by 20,000 by expanding the range of courses available over the first half of the strategy's lifetime:
- Reduce the number of adults in Ireland with unmet literacy needs, from 18% to 7%.
- Reduce the number of adults in Ireland with unmet numeracy needs from 25% to 12%;
- Reduce the share of adults in Ireland without basic digital skills from 47% to 20%.

As part of the ALL Strategy, the Minister also committed to establishing a national ALL Programme Office and to provide each of the ETBs with the resources necessary to meet the targets outlined above in the form of an additional Adult Literacy Organiser and funding through the ALL Innovation & Collaboration Fund.

LOETB have appointed a second Adult Literacy Organiser and have already submitted 3 proposals as part of the pilot phase of the ALL Collaboration and Innovation Fund, each one in conjunction with an agency that we work in partnership with. We have also already begun work on a number of exciting projects including one in conjunction with Down Syndrome Ireland and another in conjunction with Laois Sports Partnership which will begin in 2023.

LOETB and SETU Tertiary Development

LOETB is collaborating with SETU (Carlow) on a project exploring the co-delivery of Third Level programmes affiliated with SETU in FET Centres, the first of which will be delivered in Portlaoise Institute.

This arrangement would see Portlaoise Institute hosting a Higher Certificate in Computing/Business enabling successful graduates to progress into their third year of a degree programme. This would be a very significant development for LOETB which offers learners in Laois a cost-effective means of accessing third level education in our region.

Digital Construction - Future MMC provision

LOETB is leading the development of a single, accessible skills pathway in Digital Construction through strategic partnerships with key stakeholders;

- TUS (DASBE),
- Construction Professional Skillnet,
- The Build Digital Project,
- And training providers BRE Academy and T3 Training.

Skills development will be offered to those wishing to join the sector at entry level, construction operatives wishing to upskill or reskill to develop sustainable career pathways

and construction professionals requiring support in updating skillsets to keep pace with technological advancements in the sector.

LOETB has initiated the development of programmes that enhance learner currency regardless of their current employment status; from modular, stackable micro-credentials that enhance career development to traineeship programmes that offer new employment opportunities and/or direct access to higher education options.

LOETB Skills to Advance & Green Skills Provision 2022

At the end of 2022, over 2,800 learners will have participated in training under Skills to Advance, a 107% increase on last year. This year, LOETB will achieve 20% of the national target for STA. Enterprise engagement has been very strong with 65% of companies reengaging with the service.

Green Skills Provision

LOETB is the lead ETB in Green Skills provision and have contributed significantly to the national targets set out in the Skills for Zero Carbon Report. This year we are on target to achieve 77% of the national target in Renewable Energy (Domestic Heat Pump Installer) and exceed the national target for Solar PV Installer. Provision in these areas will continue to expand in 2023, achieving 93% and 431% of the national targets, respectively.

Over the past two years 319 participants, representing 100 companies, have engaged in the Lean Management Green Belt programme achieving cumulative cost savings of €9.7 million. Next year, we will pilot a Lean Management Green Belt programme in the agriculture sector, which will improve farm safety, quality, resource efficiency, and manual labour.

As part of our agriculture strategy, LOETB will work in partnership with the Agriculture Colleges and Higher Education in the development of a National Sustainable Agriculture programme which will include Biodiversity, Agriculture Science and Sustainability.

LOETB are working in partnership with National Parks Wildlife Services on the development of a Biodiversity Awareness programme, which is aimed at employees in local authorities and private contractors and construction companies.

In 2023, we expect to see a 30% increase in Remote Work provision as the "Right to Request Remote Working" is introduced. Over the next six months we plan to focus on and increase provision in the public and not-for-profit sectors.

FET Strategic Performance Agreement & Targets 2022
