15. CHIEF EXECUTIVE'S REPORT

Chief Executives Report January 2023

Schools Directorate

Schools:

• **PEDL:** The Programme to Enhance Digital Literacy (PEDL) is a five-week programme designed to increase parent's competence and confidence in using digital technologies. Currently running in ASCN Clara, Portlaoise College and Banagher College. Participants

have been invited to attend a graduation in Trinity College on Wednesday 18 January. PEDL has also received funding from the

- **SNA Webinar Series:** Monday 23 January in association with Laois Education Centre with Shaun Greville and Dr Alison Doyle will facilitate an introduction to the Pathological Demand Avoidance (PDA). This webinar is available to all LOETB teachers and SNAs.
- **First Aid Training:** Training for SNAs in our schools will take place at Midlands Skills Centre on Wednesday 18 January, Friday 20 January and Wednesday 25 January 2023.
- Ethos: National ETB Awareness week takes place from 27 February to 3 March. LOETB Schools will focus on promoting one core value per day in their school. Schools also planning on hosting local launch of ETB Patrons Framework during this week. The national campaign will include national heroes, who are all past pupils of ETB schools. LOETB will feature in the national campaign as well-known singer and former Tullamore College student Tolü Makay has contributed through a recording of her recent return visit to Tullamore College. Tolü gave of her time to meet with a current student at the school to discuss music and creativity.
- **Computer Science Teaching:** LOETB Schools' Support working with Offaly County Council to support teachers in gaining an additional qualification to teach Computer Science
- **CESI Conference:** LOETB Schools' Support invited to make a presentation at the Computers in Education and Society Ireland (CESI) conference in Galway in March. The presentation will focus on a coordinated approach in supporting schools with digital planning.
- **DEIS Planning:** A forum of one representative from Portlaoise College, ASCN Clara, Tullamore College, and Oaklands Community College was formed with the second meeting on 24 January.
- **Communities of Practice (CoP):** Ethos, Inclusion, and Digital Technologies CoPs held in January. Three more meetings for each to be held before the end of the school year.

- **UBU Your Place Your Space, (New Cycle):** UBU New Cycle commences in January 2023. Closing date for submission is May 2023
- Local Youth Club Grant Scheme 2022: DCEDIY have made a commitment to Local Youth Club Grant Scheme 2022, allocations to be announced in February 2023.
- Youth Capital Funding Scheme 2022: DCEDIY have made a commitment to Youth Capital Funding Scheme 2022, allocations to be announced in March 2023
- Local Creative Youth Partnership: Department of Education confirmed that precommitments can be made now for 2023 spend on the basis of a level of allocation for 2023 of the same order as 2022 i.e. €100,000 from DE and €30,000 from DTCAGSM for each LCYP.

- Community of Belonging: Traveller Culture: Laois Traveller Action Group (LTAG) led initiative, supported by Laois Offaly Local Creative Youth Partnerships (LCYP) through the Laois Education Support Centre (LESC) Community of Belonging are working together to develop awareness, visibility and sharing of Traveller Culture in the region. In exploring and sharing Traveller culture in our region we propose the sharing of stories as a point to begin. Stories can be told with words, images, objects, songs dance, or movement as a basis for local Traveller Culture programme for schools.
- **Jigsaw:** Providing vital supports to young people surrounding their mental health. The three original LCYP Pilot initiatives Laois Offaly, Limerick Clare and Kerry were invited by Jigsaw to work collaboratively and creatively to help each geographical area where the Jigsaw service could become more accessible for a certain group/cohort of young people who don't traditionally use the service. It could involve co-producing a project with different types of young people in the community. There are so many different possibilities. Obviously, it's about what is important and of value for the community and young people.

Music Generation:

New Choir Project with Ukrainian Community in Laois Music Centre: Music Generation Laois, through funding from Healthy Ireland Laois in Laois County Council, are establishing a Ukrainian Community Choir. This project will run from January to March and will culminate with a performance in Portlaoise at the end of March.

Long-term music provision in Montague and Hibernia DP Centres: Music Generation Laois has provided short term music programmes in both the Montague and Hibernia DP Centres since 2019. In December 2022, Music Generation Laois commenced long-term (i.e. weekly) music programmes in both locations, currently funded by Laois Partnership.

Weekly Music Club supported by LOETB Creative Youth Partnership: A weekly music club, supported by LOETB Creative Youth Partnership commenced in Laois Music Centre in September, with young people from CAMHS and Laois Travellers Action Group taking part in weekly, free of charge, music sessions.

St Patrick's Festival Dublin 2023: The Music Generation Laois Trad Orchestra, and the Music Generation Harp Collective will perform at this year's St Patrick's Festival in Dublin, on the Ceilí Stage, on Friday 17 March.

Music Generation Offaly: Ms Geraldine Relph appointed as Development Officer from 1 January.

REALT (Regional Education and Language Team) Co-ordinator:

The REALT Co-Ordinator helps Ukrainian families find a school place (primary and post-primary) for their children. In addition, the REALT Co-ordinator liaises with the Transport Section of DE and Bus Éireann to organise school transport as required. Laois has 789 and Offaly has 619 Ukrainian refugees.

FET Directorate

FET Progress Report 2022: LOETBs FET Service supported 17132 beneficiaries in 2022. This represents at growth of 41% on the 2021 figure (12075).

Supporting Jobs: LOETB's agreed target, in the Strategic Performance Agreement with SOLAS, for 2022 is 2,087. Using the economic status of learners in the immediate aftermath (4 weeks) of participation on LOETB programmes, 4,187 people reported as employed.

Creating Pathways: LOETB has adopted an integrated FET Centre approach over the last number of years which has significantly enhanced opportunities for learners to identify progression pathways for themselves within their local area. The integration of guidance services across the entire FET Service means that learners are supported to make informed decisions in relation to progression.

Access: The integrated approach also offered Community Education learners an opportunity to become comfortable in our FET Centres, leading to many learners progressing to a certified programme within the centre. The number of learners who progressed from Community Education in 2022 to a course at the same or higher level was 787 – an increase of 20% on 2021.

Progression: The number of beneficiaries who progressed from a FET course in 2022 was 5369. This represents a growth rate of 35% on our 2021 total. LOETB's FET Centres have very well-established links with local third level institutions. Tullamore FET Centre enjoys a very collaborative relationship with Technological University of the Shannon (formerly Athlone IT) whereby learners on Level 5 and 6 courses are facilitated to attend Open Days, participate in subject-specific workshops, etc. This offers learners opportunities to become more familiar with the campus and to explore course options before making informed decisions, with the support of the Guidance Service, when completing CAO applications. Similar arrangements are in place with SETU (formerly IT Carlow) whereby learners from Portarlington and Abbeyleix FET Centres, and Portlaoise Institute, are facilitated with specific workshops to encourage them to explore course options. In 2022, 195 learners progressed to third level education from LOETB's FET Centres, according to our PLSS data.

Fostering Inclusion: LOETB have placed Inclusion firmly at the forefront of our approach to FET, culminating in LOETB Inclusion Week 2022 which involved staff from across the entire ETB. There were 44 events, involving almost 3,000 staff and learners. Event themes included Interculturalism, Ability, Irish Sign Language, Mindfulness, Mental Wellness, multi-agency networking events. Four Lunch and Learn programmes were hosted by experts from the HSE, NUI Maynooth, AHEAD and the Irish Refugee Council. LOETB has made significant progress in terms of widening participation, increasing certification at lower levels, and increasing provision for Literacy and Numeracy in 2022.

The number of beneficiaries of LOETB's Adult Literacy Service increased from 2000 in 2021 to 2755 in 2022 (almost back to 2019 levels), with the number achieving certification at 650, a 76% increase in certification from 2021. LOETB engaged with 420 Ukrainian refugees, to assess their levels of English to determine the range of programmes required to address their educational needs. LOETB supported fifteen members of the Traveller Community to undertake the Traveller-specific Diploma with NUIG.

Recognising the importance of the Learner Voice, LOETB organised two AONTAS FET Learner Forum events for over 100 FET learners in 2022. Support for People with Disabilities continued through our work with the NLNs and mainstream with 2022 being the first year that LOETB provided 'personal assistance' for students across a number of our full and part time programmes.

Lifelong Learning: LOETB reached into every community across Laois and Offaly to promote lifelong learning through our Community Education service which saw our beneficiaries reach 2960, a 58% increase on last year. LOETB provided support to

communities through the Reach fund (formerly MAEDF) again in 2022. 510 individual learners received support to purchase a device to assist them in their studies enabling them to complete their courses successfully. Grants totalling €328,850 were provided to Community Groups who submitted applications to LOETB, all of which involved projects that addressed educational disadvantage.

In 2022, over 7000 beneficiaries participated in Lifelong education and training programmes. These range from full and part time programmes, and single modules to full certificate programmes.

Upskilling Through Careers: Over 3,000 employees availed of the opportunity to upskill and reskill through LOETB's Skills To Advance provision in 2022, with a considerable focus on skills for the green economy.

These include careers in the following sectors - Micro Generator / SOLAR PV /Domestic Gas Safety /Domestic Heat Pumps /Retrofit and NZEB/ Remote Working. Also, all SMEs and all enterprises of any size are being encouraged to develop a Lean Approach to their business – an approach that generates positive outcomes for the environment, the enterprise operational costs and Ireland's climate change ambitions.

Targeting Key Skills Needs: LOETB provides employment-focussed training in a strategic amalgam of sectors that takes cognisance of current labour market analysis, the area's status as a Just Transition region, LOETB's Traineeship commitments and the post-Covid learning environment. Thus, LOETB has identified the following sectors as critical to the continued growth of the Midlands region:

• Healthcare, Hospitality, Engineering, Construction, Green Skills, Agriculture and Bio-Diversity.

Healthcare

In response to the increased need for suitably qualified workers in the Healthcare and childcare industries, LOETB expanded our offering of full and part-time provision of courses in both areas in 2022. In 2022, two Level 6 Childcare were provided in Mountmellick via Employed Traineeship provision, and the new Level 5 Early Learning and Care programme was introduced in both Birr and Edenderry FET Centres.

A new Dementia Care programme at Level 5 was rolled out through a contracted training provider, which addresses skills gaps identified by nursing home employers locally and nationally.

Hospitality

LOETB have been working proactively with the Hospitality sector under Skills to Advance and traineeships for new entrants. Once the new entrants are in employment we will continue to work and engage with the sector to provide upskilling opportunities, providing them with a clear progression pathway. In 2023, we will continue to provide training in the following areas for the hospitality sector, Lean Management, Supervisory Management, Leadership and Excel, providing low skilled workers in the sector with opportunities for career advancement.

Construction & Renewable Energy

LOETB is working with TUS to develop a Construction Pathway for new entrants, current construction operatives and construction professionals. This work has included the development in 2022 of Special Purpose Award in Sustainable Construction Skills that comprises three component awards in Retrofit Insulation Skills, External Wall Application and Air Tightness and Vapour Control.

• 1,162 NZEB/Retrofit learners progressed through the National Construction Training Campus in 2022 ensuring that LOETB attained 44% of the annual national retrofit target.

- LOETB provided Heat Pump Installation QQI Level 6 to 220 learners in 2022 meeting 75% of national targets as set out in the Skills For Zero Carbon Report in November 2021.
- LOETB trained 253 learners in Micro Gen and Domestic Solar PV in 2022 (over 100% of the National Target).

Green Skills & Remote Working

Since piloting a national programme in remote working in 2019, LOETB has worked collaboratively with Grow Remote, the IDA and SOLAS on various iterations focusing on a sector that has the potential to impact significantly on Ireland's climate action ambitions. In 2022 LOETB provided Leading Remote Teams upskilling to 395 participants and Remote Work Ready training to a further 96 learners and is currently planning a community-based iteration of the programme in two rural communities in the region. In 2023, the Remote Work Ready and Leading Remote Team programmes will go through for QQI Validation as Level 5 and 6 modules respectively.

Agriculture & LEAN

The collaborative approach has also been evident in LOETB's agricultural strategy that has Teagasc, Bord Na Mona, the Agricultural Colleges at Gurteen and Mountbellew and farmers as active stakeholders. In 2022 LOETB provided the Sustainable Agriculture Traineeship to 35 learners as a key ingredient of its ongoing response to Just Transition. Recognising the need to broaden the focus to the wider farming community – as opposed to just part-time farmers employed by Bord Na Mona – LOETB has developed a Strategy in Agriculture that aims to utilise upskilling


- 1. To assist farmers in the Laois Offaly area in protecting the environment while maintaining or increasing the value of their output.
- 2. To enable farmers in the Laois Offaly area to apply knowledge and skills of agricultural management in a sustainable way.
- 3. To safeguard the viability of family farms in the Laois Offaly area by identifying new incentivised sustainability schemes available to them and giving them the skillsets required to avail themselves of the opportunity offered.

The first programme in this new suite of provision in Agriculture will be Lean Management - A programme that has attracted 117 learners in 2022 and has proven to be a huge success with SMEs in the region. The application of Lean Management Principle and Techniques to the agriculture is expected to produce significant savings to the sector and mirror the positive environmental impact resulting in other sectors

NTMA

LOETB have resumed investing surplus funds with NTMA from January 2023. NTMA are offering an investment rate of 1%. There is currently €6.5 million on investment, €3 million for one month period and €3.5 million for one week period, with the option to rollover. Currently, NTMA are offering an investment rate of 1% on all maturities out to 1 year.
