The Chairperson informed members that the Education and Training Boards Act, 2013 Section 30 (11)(a) sets out how the remaining 5 members should be selected insofar as it states that the 'core board' (16 members – 12 Local Authority representatives, 2 Staff representatives and 2 Parent representatives) are required to select at least one nominee from the following bodies specified by the Minister:

- 1. Bodies representative of Business, Industry, and Employers;
- 2. Bodies representatives of Learners;
- 3. Bodies representatives of persons engaged in the management of, or leadership in, recognised schools

The final two nominees can be selected from any of the bodies on the list of nominees provided to members. There must be a gender balance which should comprise of at least three male/two female or two male/three female.
