12. Chief Executive's Report

Schools Directorate

SEN Provision Mapping LOETB Schools

Ard Scoil Chiaráin Naofa, Clara presented at the National Induction for schools new to Provision Mapping on 1 October. LOETB Schools attended the third Provision Mapping Workshop on Multi-Modal Methods for Capturing Parental and Student Participation in Decision Making on 26 September.

Cross-Sectoral Pilot

LOETB are one of two host ETBs for a Cross-Sectoral Provision Mapping Pilot. LOETB will support five schools from JMB and ACCS management bodies with access to the Induction programme, workshops, and Community of Practice events.

Ethos: Identity Multi-Beliefs and Values (IMBV) Education:

Online teacher professional learning events will take place throughout the year on 14 October, 30 January, 20 March and 8 April. A Teacher Resource booklet will be available for teachers taking on IMBV. The resource will have a sample three-year plan with units of learning.

Inclusion: LOETB All Stars

An Inclusive Sport initiative aimed at students enrolled in special classes in LOETB schools will take place over the course of the academic year. Students from across the nine LOETB Post-Primary schools will come together on four occasions over the school year (19 November, 16 January, 20 March, and 8 May). Each session will focus on a different sport. The format of the sessions will include group warm up activities and a mini league. The year will end with a celebration and sports day. The initiative was the idea of Portlaoise College teacher, James Moloughney, and will be hosted in Portlaoise College.

Community of Practice

Community of Practice groups are working on Inclusion, Ethos, and School Planning and involve leaders and school staff from the nine LOETB post-primary schools.

LOETB Junior Maths Competition/Inter-ETB Final

The LOETB Junior Maths Competition was held on 15 October in the Midlands Park Hotel. All 9 schools were represented on the day with 42 teams competing. Congratulations to Tullamore College who came in 1st and 2nd place and Banagher College who came in third

place on the day. The top eight teams will go on to the Inter-ETB final on 28 November in Mullingar competing against teams from Longford and Westmeath ETB and Cavan and Monaghan ETB. Five LOETB schools will compete in the final, Banagher College, Clonaslee College, Oaklands Community College, Portlaoise College and Tullamore College.

TY Agri-Aware Module

LOETB schools have been availing of a TY Programme 'Intro to Ag'. This programme is a collaboration between LOETB and Agri Aware. This is an 8-week module-based course which takes an inter-disciplinary approach to explore agricultural science.

STEAM Programme

The STEAM Programme, a digital technologies initiative, in partnership with Offaly and Laois County Councils, is now well underway for a second year. All nine LOETB schools are involved in the programme, with approximately 300 students getting the opportunity to develop 21st century skills through engagement with different aspects of digital technology. The four original strands of the programme (Vex Robotics, Lego League Coding, Minecraft Design and Podcasting) are this year joined by two optional strands - Filmmaking and the STEAM Lab, which this year sees students creating school resources using VR (Virtual Reality.) The students' work, created through the programme, will be on display for all to see at the STEAM Showcase event, which this school year will take place in Banagher College on 10 April.

School Support – other digital technologies initiatives

LOETB Schools Support runs a regular Digital Community of Practice (Dig-CoP) meeting, where digital leaders in LOETB schools are facilitated to develop and share effective practice on digital technologies in schools. The most recent Dig-CoP took place on 7 October at Midlands Skills Centre, where digital leaders helped create guidelines for the ethical use of Artificial Intelligence (AI) in our schools.

LOETB has also partnered with Laois and Offaly County Councils to support and fund teachers interested in completing modules in the area of digital technology, through Atlantic Technological University (ATU). Based on the previous cohort, a number will complete six modules and go on to become fully qualified Computer Science teachers, ready to teach the subject at Leaving Cert level.

Youth Services:

Dept. Of Children, Equality, Disability, Integration and Youth (DCEDIY) - Minor Grant Scheme 2024

DCEDIY has allocated €50,000 to LOETB to administer under the Grant Scheme. The purpose of this grant is for organisations to focus on Universal Provision (Personal and Social Development), providing support and creating opportunities for all young people in the community. In total there were 4 applicants that collectively received €50,000.

DCEDIY - Resilience and Effectiveness Initiative 2024

The DCEDIY allocated €16,000 to LOETB to administer under the Resilience and Effectiveness Initiative. This is a 'UBU Your Place Your Space' initiative to support UBU Funded Organisations to deliver a more efficient and comprehensive service to young people, while ensuring that they have sufficient resilience to operate effectively in the medium to long term. In total there were 2 Applicants that collectively received €16,000.

Meeting with the Minister Roderic O'Gorman

Joe Cunningham and Linda Tynan met with Minister O'Gorman and the Principal Officer for Youth Affairs on 21 October to discuss youth service provision and funding based on the unprecedented growth population and the identified on-going and needs of young people in Laois and Offaly.

Laois and Offaly Local Creative Youth Partnership (LCYP)

The Partnership has three new members joining their Steering Group. The Laois Creative Communities Engagement Officer, the Offaly Creative Communities Engagement Officer, and Music Generation Development Officer Offaly.

Some of the projects, programmes and events supported and funded through Laois and Offaly Local Creative Partnership since May 2024

- The Foróige Youth Citizenship Programme: an event to celebrate the achievements of young people held in the Dunamaise Arts Centre.
- Laois Africa Day: an annual event celebrating the diversity of African Culture.
- Mountrath Youth Theatre: Ceramics and a 'reuse repurpose' clothing workshops
- Laois Arch Club: Button and Clay Art in Liscannor as part of their respite weekend away.
- Music Generation Offaly Music Camp: Ukulele Programme Rhode Summer Programme
- **Electric Youth:** in association with Electric Picnic performances on the Hazelwood stage Electric Picnic.
- Dyslexia Support through Creative Engagement: cooking programme Acorn Project Edenderry.
- **Science Week:** Bear Planetarium Immersive Experience using Fulldome 360-degree 3D digital projection technology Holy Family Senior School.
- Early Years Pilot Initiative with Portlaoise Family Resource Centre: The twenty-five-week initiative has come to an end and was deemed very successful by the staff, the artist, and the Local Creative Youth Partnership.
- Offaly Down Syndrome Choir and Simon Casey: produced a single, War is Over, (the John Lennon classic) along with a heart-warming video to celebrate 40th Anniversary of Offaly Down Syndrome.
- **Dagogo Hart:** A Portlaoise based poet, writer, performer, and spoken word artist worked with ten young people over eight weeks. The result a showcase of their work performed in Kavanagh's comedy club to a large audience.

Regional Education and Language Teams (REALT)

- 110,554 Ukrainian arrivals in Ireland as of 11 November 2024
 - 7-day rolling average 21 per day.
 - The number of Ukrainian citizens in Laois is remaining stable at around 1,570 for the county overall
 - The numbers of Ukrainian citizens in Offaly is remaining stable at around 1,070 for the county overall
- Movement of Ukrainian families has been significant and will continue over the coming months. This influences school places and transport.
- The GIS system has been updated from a Ukrainian enrolment perspective which will help to identify where school places may be available.
- Ukrainian will be examinable as a non-curricular Leaving Certificate examination in June 2025.

IPAS: International Protection Accommodation Services

- 32,649 arrivals as of 13 November 2024.
 - o Total Number of IPAS citizens in Laois: 458 (drop of 15% since July 2024)

- o Total Number of IPAS citizens in Offaly: 487 (increase of 20.5% since July 2024)
- 7-day rolling average 24 arrivals per day (19% children).

Music Generation Laois

- **Tionól Harp + Pipes 2024:** Over 130 Young people from across Ireland including a guest group of harpers from Glasgow took part in the MG Laois annual Tionól, a residential weekend for harpers and pipers from 1-3 November.
- Creative Connexions Sitges Live: Young trad musicians from MG Laois took part in Creative Connexions - Sitges Live in Spain from 24-27 October, including performances and workshops.
- 'We Are Music Generation' Musician Educator Day: Laois Resource Workers Nuala Kelly and Siobhan Buckley presented 'Rath NS Portrait of a Music Rich School' at a national day for Musician Educators in Galway on 30 October.
- MG Laois and MG Offaly Secondary Schools Showcase: MG Laois and Offaly
 presented a showcase concert of their LOETB music programme in secondary schools, in
 Esker Arts Centre, Tullamore on 21 October 2024 featuring Portlaoise and Dunamase
 College students.

Music Generation Offaly

- Music Generation Offaly is now working in 24 primary schools and 6 secondary schools.
- In October we hosted our 'Céilúradh Mór' events, which were part of the 10-year 'We Are Music Generation' celebrations and consisted of three very successful "Big Gigs", the first of which took place on 16 October in Birr Theatre, followed by St. Mary's Primary School in Edenderry on 17 October, and finished up on 23 October in Esker Arts in Tullamore. We invited students from our partner schools to come along and take part in the celebrations through singing and performing, and each event ended with a grand finale our reworking of the T-Rex classic 'Children of the Revolution' which our musician team changed to 'We Are Music Generation'. Over the course of the three events, we had 535 children take part, supported by teachers and staff, and we have had very positive feedback since. MG Offaly musician educators were very heavily involved in these events; from planning and teaching the shared repertoire, to performing as part of the live band on the day and singing with the children.
- MG Offaly was successful in a grant application from DCEDIY to expand on the current
 intergenerational ukulele programme and we recently launched a new community
 initiative EC'kO (Esker Community 'kulele Orchestra) with weekly rehearsals in Esker Arts
 in Tullamore. This group is open to all members of the community and is working
 towards performances at Christmas and during the Bealtaine Festival in May.
- We also received funding from Laois and Offaly CYPSC (Children and Young Persons Services Committee) to continue delivering programmes to children living in IPAS in Banagher, Birr and Tullamore through a variety of ways, including school programmes, after school hubs, and visits to IPAS centres.

• The Academy of Music are hosting their very first Christmas Concert in Tullamore Church on Sunday 1st of December and will feature performances by Academy students and staff, The Academy String Ensemble, and Chamber Choirs.

FET Directorate

Demonstration Park for MMC, National Construction Training Campus, Mount Lucas

LOETB has completed the Groundworks tender as part of Phase 1 of the Demonstration Park for the Modern Methods of Construction at Mount Lucas. This contract consists of the construction of access roads, a new sub-station, and the installation of the housing pads.

We are continuing to work with the preferred contractors for the Phase One housing units and it is our intention to agree contracts in principle before the end of the year.

We are also in the process of developing a management strategy for the park, identifying target audiences, and park functions in Years 1-3 of the development.

LOETB Climate Solutions Summit, 2025

LOETB is the lead FET provider nationally in Construction (incl. MMC), Agriculture (Sustainable Ag and Bio-Diversity) and Green Skills. As part of our promotional strategy, we will host a Climate Solutions Summit in Q1 2025. The summit will target various audiences including the Community and Voluntary sector, Industry, Local Authorities and Government Departments and will provide a forum for discussing key challenges and some of the solutions that we have collaboratively developed with our partners.

LOETB Strategic Performance Agreement 2025-2027

LOETB will meet with SOLAS on 27 November to plan our next Strategic Performance Agreement. The agreement will set out a series of targets for the FET Service under a range of headings. These include:

- Delivery of Transversal Skills
- Widening Participation (Inclusion)
- Delivery of Key Skills needs
- Workforce Transformation
- Progression within/from FET
- Delivery of Green Skills

LOETB continues to be one of the highest performing ETBs in the FET sector. Throughout the period of our last Strategic Performance Agreement, our FET beneficiary figure has grown by 86%, meaning that approximately 23,000 FET beneficiaries will be supported by LOETB in 2024.

FET Estates Strategy

As part of our commitment under the Climate Action Plan, we have developed a FET Estates Strategy. This strategy outlines our building stock and prioritises works that will be required to improve the energy rating of our FET buildings. These significant works will include retrofitting, Mechanical and Electrical, windows, doors and roof works. New funding streams have become available to LOETB to support these works including a Minor Capital Works scheme and a new Devolved Green Capital scheme. The upgrade works will commence in 2025 in Birr Outdoor Education and Training Centre as it is one of the highest energy consumers across our FET Estate.

New Provision 2025

As part of our national role cross various sectors, LOETB will develop the following new programmes in 2025:

Construction

- MMC Traineeship: MMC Operative (Level 5)
- MMC Technician Apprenticeship (Level 6)
- MMC Project Manager Apprenticeship programme (Level 7)

These programmes will be delivered using a modular entry/exit model, providing both new entrants and existing employees in the construction sector a visible accredited learning pathway.

In 2025, LOETB will launch a range of new accredited micro-credentials in MMC to include:

- ZEB Awareness
- Overheating Awareness
- District Heating
- SOLAR PV System Design
- MMC Awareness
- How Digital Technologies Are Used in MMC (Including BIM)
- Sustainability in MMC and the Impact on Construction and the Environment
- MMC Awareness Local Authority focus

We also plan to further broaden our training provision in 2025 by incorporating established qualifications into our construction portfolio. These include:

- NVQ Diploma (Level 4) in Construction using Off-Site Manufactured Assemblies,
- NVQ Diploma (Level 5) in Occupational Work Supervision
- NVQ Construction Site Supervisor Diploma (Level 6)

Agriculture

Community Education and Adult Literacy for Life

- Digital Help Hubs established in local Marts.
- Workshops within the community on Succession and Inheritance, Accounting, Financial, Bookkeeping, and Grant and Scheme Application
