6. CHIEF EXECUTIVES REPORT

The CE presented the following report to members.

Schools

Current Regulations

Schools are continuing to respond to changed learning environments and a significant amount of work has taken place to support students and staff in ensuring that schools have stayed fully open. It has been a very busy term with a wide range of activities taking place in all schools while adhering to Covid 19 guidelines. The dedication and efforts of all school staff, students, boards of management and parents is acknowledged and appreciated.

Training for Chairpersons and Secretaries of school Boards of Management

Training has taken place this week (Monday December 7). Additional training for all board members to support them in their roles will take place in the New Year. Board of Management Agenda and Minutes of Meetings templates have also been updated.

Circular No. 0069/2020

New Arrangements and Procedures for <u>Appeals under Section 29</u> of the Education Act 1998 are effective from 12 November 2020 onwards. These new appeal provisions in sections 29 to 29F are designed to work alongside the wider admissions framework in the 2018 Act. The new arrangements mean that there will no longer be an appeal to the ETB, following a review by the school Board of Management, where applicable; appeals will now go directly to the Department of Education. The appeals process includes:

- Procedures for appeals in relation to refusal to admit a student to a school, where the decision to refuse admission is due to the school being oversubscribed.
- Procedures for appeals in relation to refusal to admit a student to a school where the
 decision to refuse admission is due to a reason other than the school being
 oversubscribed

 Procedures for appeals in relation to permanent exclusion of a student from a school or suspension of a student from attendance at a school for a period or periods totalling not less than 20 school days in a school year

All LOETB schools are aware of the new procedures which are available on the Department's website along with a Frequently Asked Questions (FAQ) document to assist with queries in relation to the new procedures.

Circular Letter 0073/2020

Updated Guide to Child Protection and Safeguarding Inspections (CPSI) in Primary and Post-Primary Schools has issued to all schools. This revised Guide provides greater clarity on the provision of a Child Protection and Oversight Report (CPOR) to Boards of Management in Centres for Education (Youthreach) and on the review of the school's Acceptable Use Policy (AUP) for Information and Communications Technology (ICT). It also removes a very small number of ambiguities from the original CPSI framework. All new CPSIs commenced after 3 November 2020 are being conducted in accordance with the new revised Guide.

Circular 0077/2020

Grant Scheme for ICT Infrastructure – 2020/2021 School Year. As part of the implementation of the Digital Strategy for Schools 2015-2020 Enhancing Teaching Learning and Assessment, there was a commitment for grant funding of €210m for ICT Infrastructure to be distributed to schools over the five years of the Strategy. €160m has issued over the lifetime of the strategy to date, with this representing the final tranche of funding.

€40m is issuing now in the form of a grant payment to all eligible schools. A further €10m in grant funding is also issuing now based on specific criteria. Schools can prioritise spending plans for this grant, if required, to address ICT needs identified in the context of the current public health crisis. This can include the purchase of ICT devices that can be shared with students who do not have access to devices to enable the continuity of learning during the public health crisis. The Department also recently issued Circular 0074/2020, requiring schools to put in place a communication and learning platform that supports schools to respond in the event of a partial or full school closure in the future. This funding can be utilised to support the implementation of the requirements of that circular.

Music Generation

With the closure of schools and education centres in March, Music Generation Laois (MGL) moved online, delivering programmes via live internet teaching using zoom and pre-recorded video tuition. The uptake was very positive, with engagement from around 75 percent of students across schools and Laois Music Centre participants. The Musician Educators (tutors) of MGL are commended for their adaptability, energy, and commitment to continue their work during this period.

The new academic year in September brought challenges, re-enrolment in Laois Music Centre was sustained as per the previous year, however 55% of participating schools postponed MGL programmes until 2021. However, this drop-off was then offset with an increased interest in new schools and youth settings, in many cases to counter the difficulties young people were facing, due to the extent of cancelled extra-curricular activities.

Since September, with the support of Creative Ireland Laois in Laois County Council, the Laois Offaly Local Youth Creative Partnership in LOETB and general supports from LOETB and Music Generation National Development Office, new programmes have commenced in a number of locations: St. Fergals College Rathdowney, Dunamase College Portlaoise, The Rock National

School in Mountmellick, Cloneyhurke National School, Mountrath Youth Theatre, Rathdowney Youth Café, Portarlington Youth Garda Diversion Project and Portlaoise Youthreach as well as extending current provision in Rath National School and Barnashrone National School.

In addition to weekly programmes, Music Generation Laois presented a socially distanced Music Network concert in Stradbally in September, the first of its kind in the county. The annual Tionól for Harps and Pipes at the October midterm was primarily online, and a resounding success, the first Music Generation funded Creativity and Collaboration event to go ahead during the Covid-19 Pandemic. The festival included a professional live-streamed performance from the Dunamaise Arts Centre.

Further responding to the needs of the current climate, MGL, supported by the Creative Ireland Laois Positive Aging and Well-Being Challenge Fund, developed Musical Memories, an intergenerational song project with Mountmellick, Abbeyleix and Shaen Community Hospitals and Paddock National School. Residents and children are forging connections through songs and letter-writing. The Bandwagon, mobile performance stage, with partners Laois School of Music, is preparing to tour the 3 participating hospitals in December, with a festive themed programme of music for residents to enjoy outside their windows.

<u>DCEDIY</u> (Dept. of Children, Equality, Disability, Inclusion, and Youth) - UBU Your Place Your <u>Space</u> (formerly Targeted Youth Funding Scheme)

The new UBU Your Place Your Space scheme began on 1 July 2020. LOETB were allocated €113,977 for the 3 successful funded organisations for Q3 and Q4 of 2020. LOETB Youth Services managed the successful transition of the 3 funded organisations from the extended TYFS funding in Q1 and Q2 of 2020 over to the new UBU Your Place Your Space scheme in Q3 and Q4 of 2020. As per UBU guidelines, LOETB was obliged to conduct Performance and Oversight reviews of each funded organisation. These Planning and Progress Review meetings were completed by 5 November 2020.

Following reviews, all funded organisations were required to submit confirmation of renewal of UBU funding for 2021. This application was submitted to DCYA on 30 November 2020.

Youth Capital Funding Scheme 2020 for Targeted Staff Led Youth Services

The DCEDIY allocated €20,000 for this Grant Scheme. The grant was oversubscribed by €11,050.00, however LOETB applicants were successful in securing full funding of €31,050.00 to Offaly Traveller Movement, Youth Work Ireland – Midlands and Youth Work Ireland – Laois. COVID restrictions have caused delays in general across the board in getting works carried out as per approved application. It is expected however that all works will be completed and supporting documents submitted by week ending, 11 December 2020.

Local Youth Club Grants Scheme 2020

The Dept. allocated €69,150 to LOETB for this Grant Scheme in 2020. 38 applications were received and awards were made to 35 successful Youth Clubs/Groups across the two counties.

LGBTI+ Youth Service Grant Scheme 2020

The Dept. allocated €5,000 to LOETB for this Grant Scheme in 2020. The initiative is intended to provide for additional youth worker hours dedicated specifically to supporting young LGBTI+ people. The award was made to one successful applicant:

• Youth Work Ireland - Midlands/Tullamore Youth Project € 5,000.00

Youth Services Covid-19 Minor Grant Scheme and ICT Investment Grants

In November, awards of €4,000 were made to 21 successful applicants under the Covid-19 grant scheme and €12,088.64 was awarded to 16 successful applicants under the ICT Investment grants.

Local Creative Youth Partnership (LCYP)/Creative Arts Programme

The LCYP was successful in securing further funding of €100,000 for 2021. The LCYP steering committee and coordinator identified key thematic areas that informed and developed the work plan, which was based on the identified needs of young people. The 2020 work plan was revised 4 times due to COVID-19. In response to COVID-19 restrictions, the work plan was continuously adapted to ensure successful delivery of 2020 work plan.

Overall, there were 38 initiatives funded through the LCYP. 19 of these creative programmes were awarded through an application process. 19 were funded through a partnership programme approach. One third of all current year funded youth services/clubs and groups benefited directly through additional non–duplicated creative activities.

<u>Local Creative Youth Partnership (LCYP) Creative Ireland July Stimulus Pack</u> Further funding of €50,000 was allocated to LCYP through the Government Stimulus Package. Awards of €46,950 were made to 16 successful applicants in December 2020.

- 5 x Youthreach Centres and 1 CTC) €26,722.86
- 4 School Completion Programmes € 9,098.25
- Creative Activation Package 2020 €11,128.89 awarded to 6 Youth Clubs/Groups in Laois and Offaly

Youth Work Committee (YWC)

Following the establishment of a new YWC in September 2020, an online meeting was held on 25 November 2020. The meeting included updates and information sharing of youth service provision on a local and national level. Strategic development and collaborative opportunities with other youth service key stakeholders, e.g., Creative Ireland/DES - Local Creative Youth Partnership network. The planning, development and time-frame for a new Youth Work Plan.

Further Education and Training

Mitigating against Educational Disadvantage Fund

The Dept. of Further and Higher Education and SOLAS announced a fund in November to support learners and communities who may be experiencing some form of disadvantage in accessing Further Education and Training.

LOETB undertook to contact and support Community Education groups to apply for the fund despite the considerable challenge presented by the timeframe (all applications must be completed and processed before 31 December 2020). Alongside this, LOETB used the fund to allow individual learners to purchase a device that would benefit their learning. Through the fund, LOETB has supported 24 Community Groups and approximately 300 FET learners leading to a total drawdown of approximately €475,000.

FET Service 2020 & 2021 bid

The FET Service is currently preparing the 2021 bid and finalising 2020 figures. Despite the considerable challenge presented by Covid-19, the FET service worked with approximately 12,000 beneficiaries (with a retention rate of over 85%), whilst progression rates improved to 75%.

The 2021 bid will see a further increase in our integrated FET Centre model of provision and, in line with our new Strategic Performance Agreement (draft), target new areas including:

- NZEB and Retrofitting
- Digitalisation and Remote Working
- The Green Economy and Sustainable Development (as part of our commitment to Just Transition this will focus on both Skills and Inclusion in the Peatland Communities)
- Medtech/Biopharma

FET Brand Awareness

The FET Service is developing a marketing strategy to heighten awareness of our provision and services. This will include a coordinated and sustained approach to promote the services locally and regionally through the various media channels.

A promotional video was launched recently outlining the services available on the Tullamore FET Campus including:

- Tullamore FET Centre
- Midlands Skills Centre
- Tullamore Community Training Centre
- Tullamore National Learning Network

It is our intention to produce similar promotional videos for all of our FET Campuses and services across the LOETB region.

Developing the FET Service: Update

This year, the FET Service took on a number of projects to further develop the service, increasing accessibility for learners and visibility in our communities.

The fit out of the *FET Information Centre in Portlaoise* has commenced. This centre will have a very positive impact on our FET Service providing learners with a single access point for all LOETB FET provision.

The new *FET Centre in Birr* is nearly complete and we plan to move into it in early January. This new facility will provide a comprehensive suite of full and part time programmes for learners in Birr and South Offaly.

The new extension in the Midlands Skills Centre in Tullamore has commenced and will provide a custom-built training facility for employers and employees. This development will form a key part of our services to employers and employees.

The *expansion of our facilities in Mount Lucas* is nearly complete providing a custom-built facility for the new scaffolding apprenticeship. This development has also allowed us to repurpose the existing facilities into an NZEB/Retrofitting training site. This site will form part of the national NZEB delivery strategy in partnership with SOLAS.

Finance

Budgets

Ongoing monthly monitoring of all school and centre budgets is being carried out. Expenses related to Covid-19 are being tracked and monitored.

Finance Shared Services

LOETB are on schedule to migrate to the new financial management system on 1 January 2021. Staff training was completed in November with additional training days in December for anyone who could not attend in November. Testing of the system is near completion and no major issues identified.

Summary Finances

Summary of finances to end of October 2020:

<u> Creditor Payments – Quarter 3 2020</u>

1,452 invoices, amounting to €3,473,087.20, were paid in the third quarter of 2020. Of these, 71.49% were paid within 15 days of receipt of invoices, and a further 27.06% were paid within 30 days.

18 Purchase Orders for €20,000 or above, totalling €2,189,628.74 inclusive of VAT (includes purchase of site for new school, Dunamase College), were paid in the third quarter of 2020.

A number of site meetings have been held to date. Various design options prepared by Design Team. It is expected that a Stage 1 report will be prepared and submitted in Q1 2021.

Ard Scoil Chiaráin Naofa, Clara

A proposal for a new building on a site acquired by Offaly County Council has been submitted to DES. A Stage 1 report has been submitted and we await a response.

Portlaoise College and Portlaoise Institute

Site meetings have been held and the next site meeting will take place in January 2021. Work is ongoing in the background by MCOH in preparation for Stage 1 report.

Tullamore College

Lots 1 and 2 completed. Acoustics works to be completed by mid-December 2020.

Geographical/Topographical Surveys started on site November 2020.

Dunamase College - Tower Hill

Refurbishment works commenced in October 2020 and are ongoing until 17 March 2021. Site meetings are held every two weeks. Works are currently on schedule.

Portlaoise Information Centre

Design team and contractor appointed; works will commence on 7 December 2020.

Midlands Skills Centre, Axis Business Park

Site meetings have been held and contractor appointed; works will commence in early December 2020.

Refurbishment at Banagher FET Centre

Work is underway to upgrade the toilet facilities and the expected completion date is 11 December 2020.

<u>Dunamase College - New School</u>

Design Team mini competition posted on eTenders; closing date for responses is 10 December 2020.

Scheduled maintenance and upgrades across the wider network infrastructure are ongoing.

IT advice and support ongoing for facilities development.

Ordered and commissioned 500+ devices for the provision of continuity support across FET centres and all Schools.

Commissioning 150 devices for FET disadvantaged programme (MAED).

Corporate Services

Health and Safety

The Safe Check conducted by Health and Safety Consultants, Peninsula, has recommenced and is due to be concluded presently. Reports will be issued to Principals/Managers post-inspection.

Risk Management

The Risk Register and Risk Management function has undergone a review and is currently in a transition phase to a new model of analysis and reporting. This was brought to the recent Audit and Risk Committee for approval. The migration to the new model should be finalised by Q1 2021.

Communications

A Customer Service Charter has recently been completed and the Customer Service Action Plan is currently being drafted. In addition, the digital communications policy and procedures have been finalised.

COVID-19 Update

The working group continues to monitor the evolving situation. An additional €55m has recently been announced as a further support in the area of minor works, while a further €40m has been allocated under the Digital Strategy for schools 2015–2020, with an additional of €10m provided specifically for measures to provide for the continuity of teaching and learning using digital technology.

Dunamase College and Oaklands Community College have recently had Covid-19 Inspections.

The Government recall of ViraPro had no immediate impact on our schools/centres. In early September, due to delayed delivery of orders by certain suppliers a small number of our schools took delivery of a small quantity of ViraPro sanitiser, as a "stop-gap" measure. These supplies were depleted quite quickly and subsequently replaced by the sanitiser on the original order. The supplier of aforementioned sanitiser has now been removed from the official list of suppliers.

Chairmans Initials

Freedom of Information

Two additional freedom of information requests have been received. One has just been finalised and one is currently being processed. One member of staff has completed FOI training in recent weeks.

Data Protection

One data breach was reported in October 2020. It was deemed to be a moderate risk involving a small number of subjects. Mitigation steps were followed and the situation was controlled. A report issued to the Data Protection Commissioner on same. A subsequent response indicated that they considered the matter contained and no further action was required.

Members thanked the CE for his comprehensive report. A discussion took place thereafter.

Members raised concerns regarding CL0069-2020 and the moving of Section 29 Appeal Hearings from LOETB level directly to the Department of Education and Science. Members felt that access to the Hearings at LOETB level was convenient for families as they were held locally. Members asked the CE to seek clarification from the DES regarding the location of the S29 Hearings going forward. In response to a query from a member, the CE explained that the new system was in response to the Admissions legislation and ensures consistency across all school sectors.

A member asked if the additional youth work funding will create extra posts for youth workers in staff-led projects. The CE explained that the funding was not for additional staffing but would consolidate existing staffing and provide additional capacity for services.

A member asked the CE how groups will be identified for the Mitigating against Educational Disadvantage Fund. The CE explained that LOETB contacted all local community and youth groups and advertised for applications on local press, social media, and the LOETB website.

A discussion took place on the members' participation on LOETB interview Boards. The CE informed members that HR will contact each member directly to check their availability to sit on future interview Boards to ensure that all members interested in participating on Interview Boards have the opportunity to do so.

A member suggested that Laois would greatly benefit from a centre similar to the National Construction Training Centre in Mount Lucas. The CE confirmed that LOETB has commenced research for a proposal that may lead to the establishment of a Centre for education and training in the area of Climate Action and Sustainable Development. Given the identification of Portlaoise as a designated centre by Government as part of its Climate Action Plan, it is likely that any submission for a new centre would identify Laois as its location.
