### **CHIEF EXECUTIVES REPORT:**

## **Education Services**

School Patronage Application

LOETB is applying for patronage of the new second-level school which the DES has announced for Portlaoise. The application is being made in partnership with An Foras Patrúnachta. The new Community College will be co-educational, multi-denominational and provide for an Aonad (a unit with provision through Irish) with the aim of opening a separate Gaelcholáiste once sufficient enrolments are secured.

The proposed new Community College will offer an educational experience that meets the needs of the evolving wider community which is becoming increasingly more diverse. The patronage application must be submitted by 8 June. At present, expression of interest forms are being distributed widely and the total number of parental preferences received will be considered by DES when making their decision.

College for Everyone

Portlaoise College is one of the first schools outside of Dublin to be granted the title of '21st Century School of Distinction' by Trinity College Dublin and the US organisation College for Every Student. This award has been given to us as the school excelled in the introduction of the 'College for Every Student' (CFES) model into school this year. This programme is designed to increase college awareness throughout the whole school. CFES activities are all categorised under three headings; leadership, mentoring, college awareness.

# **Further Education and Training Services**

**Construction Traineeship** 

The FET Service is currently developing a Construction Traineeship for new entrants. This is a collaborative project with CIF, City & Guilds, SOLAS and the DSP. LOETB will act as the lead partner with two other ETBs to develop a regional approach to provision. The project will provide access into employment in the Construction sector.

**FET Survey** 

The FET Service has developed a survey for all FET Learners. The survey has been distributed via text and e-mail with a closing date of 31 May. The data will provide a baseline data on current provision, and will act as a benchmark of performance going forward.

**Integration of FET Services** 

1. Introductory Construction courses have been developed for Youthreach participants using Contracted Training.

2. Progression options in Healthcare will be provided as an option for Level 5 VTOS and PLC students at Abbeyleix FET Centre.

### **Youth Services**

Youth Club Grants

The Local Youth Club Grant Application form is available on our website and all group that received funding in 2015 have also been notified. The closing date for receipt of application is 17 June.

#### **Administrative Services**

**Human Resources** 

We currently have placed advertisements for 30 teaching posts on Education posts.ie and on our own website. The closing date for applications is 30 May.

Garda Vetting Training and Health and Safety Training was rolled out to Further Education staff on Thursday 19 May.

Corporate Services

We met with DES officials regarding accommodation needs for Oaklands Community College and received a positive response to a proposal for alternative accommodation in the town.

A Risk Register is currently being prepared for our school in association with IPB.

Finance

We have received approval for rental of accommodation for Ard Scoil Chiaráin Naofa Clara for the next school year. This will facilitate additional students with special education needs as part of our ASD unit.

KOSI Corporation has been appointed by the C&AG to conduct an audit of our operations for the 2015 financial year. We expect the audit to commence in the coming weeks.

Procurement

The analysis of tenders received for furniture and equipment for the new Tullamore College has been completed and recommendations are being forwarded to DES for approval.

We received approval from DES to furnish and equip a new Art room and Music room at Oaklands Community College and tenders are being sought presently.

#### **Overdraft Facility:**

Laois and Offaly ETB's overdraft facility, per sanction received from the DES, is due to expire on 16 June 2016. The overdraft facility currently in place is for €3.3 million, but as LOETB has taken over training services from LWETB since 1 March 2016, the overdraft facility needs to be increased to €4 million.

In this regard, as CE of Laois and Offaly ETB, I propose that the Board should borrow an amount of up to €4 million for the purposes of carrying out the Board's functions; this overdraft facility to be put in place for one year.

Accordingly, two meetings of the Board are necessary; one to first consider the proposal and, if it is decided in principle that the proposal should be accepted, a second to accept the proposal, having obtained the consent of the Minister.

Members agreed that the proposal should be accepted.
