7. CHIEF EXECUTIVES REPORT

Schools

State Examinations

The State Examinations have concluded in all schools and reports from all concerned were positive.

Youth Services

National Quality Standards Framework (NOSF)

The Dept. of Children and Youth Affairs (DCYA) have allocated €225,695 for the Special Projects for Youth (SPY) programme in 2018. Currently the LOETB Youth Officer is carrying

out quality standards reviews with the SPY-funded projects in our region, namely Youthwork Ireland Laois, Youthwork Ireland Midlands, and Offaly Traveller Movement.

Capital Funding Scheme 2018

The DCYA has allocated €35,000.00 for this Capital Grant Scheme in 2018 which is limited to SPY projects in Laois and Offaly. The focus of the grant is to support initiatives such as the purchase of equipment and/or minor health and safety improvements, upgrade to premises, including painting or redecoration and upgrade of kitchen and toilet facilities.

Local Youth Club Grants Scheme 2018

The DCYA has allocated €55,165.22 for this Grant Scheme in 2018. The Scheme supports voluntary youth club activities for young people; with priority being given to young people between the ages of 10 and 21. In total 48 Youth Clubs/Groups have applied for the grant and the successful applicants will receive their allocations in early October 2018.

Further Education and Training

Strategic Performance Agreement

The Strategic Performance Agreement with SOLAS, including targets for our FET provision from 2018-2020, has been agreed.

Schools Reconfiguration for Diversity Process

Offaly County Childcare Committee carried out a survey on behalf of LOETB of parents using Childcare services in Edenderry between 28 May 2018 and 26 June 2018. A draft report is currently being prepared.

Freedom of Information requests are on-going and are being answered within the designated time frames. To date 5 FOI requests have been received in 2018.

Audit of 2017 Financial Year
