## **Background and Statistical Information**

Laois and Offaly Education and Training Board (LOETB) was established on 1 July 2013 under the Education and Training Boards Act, 2013, as an amalgamation of the former County Laois and Offaly VECs. It has a corporate structure which is made up of a democratically-appointed committee and a management (executive) team. Laois and Offaly ETB serves the two County areas of Laois and Offaly which has a population of circa 162,735 people.

The services we provide include second-level education, Further Education and Training, and Prison Education in addition to other community based education programmes and services. All services are delivered at local level.

# **Geographic Areas and Locations**





## Statement of Services - Schools

The Director of Schools provides a leadership role across the LOETB's Post-Primary Education Services and Youth Services across Laois and Offaly. All schools are co-educational and are inclusive of all students. Junior Certificate and Leaving Certificate programmes are provided as well as Transition Year, Leaving Certificate Applied and Vocational Programmes. Youth Services manages and administers a number of funding programmes that support the work of youth clubs and organisations in developing and enhancing the lives of young people in communities throughout Laois and Offaly.

#### The following priorities have been identified for 2019:

#### 1. Child Protection

Provision of resources/support for schools in ensuring compliance with DES child protection inspection process.

#### 2. Leadership Support

Provide support and training opportunities for middle leaders, with particular reference to AP1 positions.

#### 3. Looking at our School

To provide opportunities for schools to explore various routes towards school improvement, using the Looking at our School Framework.

#### 4. Curriculum and Assessment Development

To develop innovative curriculum and assessment pathways for engagement and progression. A particular focus on School Self Evaluation (SSE) and Wellbeing for the school year 2018/19.

#### 5. Profile and Communications

To communicate, present and share the work and achievements of the LOETB to improve the profile of the organisation and engagement with its work.

#### 6. Organisational Effectiveness and Governance

To develop the LOETB school governance and organisation structures, processes, skills and competences to innovate in the achievement of the vision.

#### 7. Partnerships and Strategic Relationships

To build on existing strategic relationships and develop new ones to support and connect SSE development and implementation.

#### 8. Engagement and Networks for Innovation

To work with schools, principals, deputy principals and teachers, to build capacity for change through formal and informal Learning Communities.

#### 9. Youth Employability Initiative

The specific aim of this initiative is to help young people 16-24 (focus on 16-18) years who are not currently in employment, education or training.

#### 10. DCYA 2019 Area Profile, Needs analysis and Service Requirement

LOETB will complete the DCYA 2019 Area Profile, Needs Analysis. Once the Service Level Agreement between the DCYA and ETBI is agreed and approved, and the Area Profile, Needs Analysis and Service Requirement are submitted to the DCYA, it is intended that funding currently administered by City of Dublin Youth Service Board (CDYSB) will be transferred to LOETB for governance of projects in its region.

#### 11. Local Creative Youth Partnership/Creative Arts Programme

The Department of Education and Skills awarded €100,000 to the Laois and Offaly Local Creative Youth Partnership (LCYP), of which LOETB is the lead agency. LOETB will appoint a Coordinator to manage the roll-out of projects under this programme.

## Statement of Services - Further Education & Training

The Director of Further Education and Training (FET) is responsible for the delivery of high quality and responsive FET provision, the governance and management of FET operations, and workforce planning and performance management in FET.

The following priorities have been identified for 2019:

#### 1. Enhanced Provision

The FET Services will provide full and part time FET programmes to over 11,000 beneficiaries in Further Education and Training Centres across Laois and Offaly.

#### 2. Construction programmes

LOETB will also provide additional programmes in consultation with industry partners at Mount Lucas, the National Construction Training Centre.

#### 3. FET Centre model of provision

In line with our Strategic Performance Agreement with SOLAS, we will focus on further developing the FET Centre model of provision. This provides for multiple services on single FET sites and will ensure that our FET Services are more accessible to learners in the region.

#### 4. Bio-Pharma Facility

LOETB will open a new Bio-Pharma Training facility in Tullamore targeting new entrants, current employees, and employers in the region in line with the sectors growth and employment opportunities, as identified by the Strategic Labour Market Research Unit (SOLAS) and the reports from the Expert Group on Future Skills Needs for the Midlands Region.

#### 5. Apprenticeship

LOETB will expand Apprenticeship provision in Tullamore (Electrical) and Mount Lucas (Scaffolding), thereby expanding the range of provision available to learners.

#### 6. Skills to Advance Strategy

LOETB will enhance training options for those currently in employment in the region through the Skills to Advance strategy. The current employment landscape in this region means investment in the development of current employees is a more attractive option than hoping to access required skills in an extremely competitive labour market.

#### 7. Quality Improvement Plan

A full review of LOETB's Quality Improvement Plan preparing for the agreed Self Evaluation and Statutory QQI Review of all Quality Assurance Processes.

#### 8. Quality Assurance System

The development of a Common Quality Assurance system for all FET Services in LOETB.

#### 9. Cooperation Agreements

Expansion of revised Co-operation Agreements with Athlone IT and IT Carlow, offering greater progression options into Higher Education from LOETB FET provision.

#### 10. Employment Strategy for People with Disabilities

Ensure that LOETB's commitments presented in the Comprehensive Employment Strategy for People with Disabilities are progressed.

#### 11. Initial Learner Assessment

Further development of a consistent approach to initial learner screening and assessment.

## Statement of Services – Organisation Support and Development

The Organisation Support and Development (OSD) function is one of leadership of the administration function across LOETB. The Director of OSD is responsible for the Governance and Management of the ETB's administration and oversees the management of the ETB's resources across the Human Resources, Corporate Services, Finance, Procurement and Buildings, and ICT Functions. All of these areas have a broad remit and are essential to ensuring the organisation is compliant with requirements in relation to corporate governance while being in a position to fulfil the requirements of an extensive range of legislation.

The following priorities have been identified for 2019:

#### 1. Procurement and Buildings

#### **Buildings:**

The following Projects will be progressing in 2019:

Ard Scoil Chairain Naofa, Clara - major redevelopment

Oaklands CC - new school building

Clonaslee College – additional accommodation

Dunamase College - acquisition of site for new school building

Portlaoise College - Development of ASD units

Portlaoise Institute - Additional Accommodation

Temporary Accommodation will be provided at Ard Scoil Chiarain Naofa, Clara And Oaklands Community College, Edenderry.

#### Procurement:

LOETB will continue to sign up to the OGP frameworks where relevant. LOETB will continue to review areas of aggregated expenditure where OGP frameworks are not in place and these will be progressed through LOETB's own procurement guidelines/frameworks.

#### 2. Corporate Services

#### Governance:

A new Code of Practice for the Governance of ETBs has been introduced and LOETB will be reviewing its systems and practices to work towards compliance with the Code.

#### Health, Safety, and Welfare at Work:

LOETB will continue to work with schools and centres to ensure we comply with Health, Safety and Welfare at Work Acts. LOETB is also part of a pilot project which is underway nationally.

#### 3. Finance

LOETB will continue to operate in accordance with legislative requirements and best practice. LOETB will work with ESBS on the roll out of the finance shared services. Way 2 Pay will be rolled out to all Schools in 2019.

#### 4. Human Resources

LOETB will continue to work with ESBS on the roll out of the payroll shared services.

#### 5. Information Communications Technology

The role of ICT continues to evolve across all LOETB services. Its importance in underpinning administration and governance along with teaching and learning has grown significantly.

ICT will support the roll-out of the Digital Strategy for Schools 2015-2020 and the Technology-Enhanced Learning Strategy for FET staff.

LOETB will further develop its Business Continuity Plan.
