6. MATTERS ARISING FROM MINUTES:

Cllr Sinead Dooley asked if there was any update on the Bank Overdraft which had been discussed at the last meeting. The Chief Executive confirmed that this will be covered under agenda item 9.

7. PRESENTATION OF ETB PROGRAMMES AND SERVICES:

Joe Cunningham, Chief Executive along with Linda Tynan, Director of Education Services, Marie Bracken, APO, Sadie Aherne, APO and Padraig Boland, Youth Services Manager, made a presentation to members on all of Laois and Offaly ETBs programmes and Services.

8. CHIEF EXECUTIVES REPORT:

Joe Cunningham, Chief Executive presented a report to members as follows;

Education Services

Inspections

A number of inspections have taken place in our schools since the term began and the reports have been very positive, acknowledging the excellent teaching and learning taking place and also making recommendations to further improve efforts.

Staffing

Chairma

Two Posts of Responsibility (one each at Tullamore College and Oaklands Community College) will be advertised presently.

Music Generation

We are part of Music Education Partnerships (Laois and Offaly/Westmeath) that successfully applied for funding under the Music Generation Programme. This initiative will be funded by DES at the end of the respective programmes.

Laois School of Music

The classes and operation of Laois School of Music (a partnership with Laois County Council) have transferred from Portlaoise College to Portlaoise Youth Education Centre, Railway Street, Portlaoise.

Further Education and Training Services

Training Services

As and from 1 July 2014 Laois and Offaly ETB took responsibility for training services delivered in the counties of Laois and Offaly. A Memorandum of Understanding was put in place with Longford and Westmeath ETB until 31 December 2014 to manage the operations of training services on our behalf. This followed a requirement from the Dept. of Education & Skills (DES) to submit a plan to ensure the continuity of services through the transfer process.

Mount Lucas Training Facility

As part of the transfer of training services to ETBs, and in line with legislation, ownership of the facility at Mount Lucas transferred to Laois and Offaly ETB on 1 July 2014. A Licence Agreement is being put in place with Longford and Westmeath ETB to facilitate the on-going delivery of training services at the Centre.

SOLAS have contracted Deloitte to prepare a business case for the transfer of their Assessment Function (currently carried out at SOLAS Head Office) as it is **not** part of their remit under the Further Education and Training Act. Mount Lucas will be considered as part of this process.

Further Education and Training 2015 Service Plan

SOLAS, in consultation with ETBI, are revising the process for funding for 2015. We are currently planning our Further Education provision for 2015 and working with Longford and Westmeath ETB in relation to the Training element of our provision.

Training Services

DES has requested a submission by 1 December on the resources necessary for Laois and Offaly ETB to manage the delivery of training services in the counties of Laois and Offaly. SOLAS have been asked to facilitate this process.

Youth Services

Youthreach provision

Following a review of provision across the two counties, 25 places have been transferred from Mountmellick Further Education Centre to Portlaoise Youth Education Centre, effective from 1 September.

Capital Grant

ETBs have been requested to administer a capital fund (€0.5M) for youth work organisations towards minor works (e.g. equipment and maintenance of premises). Recommendation will be made by ETBs, with decisions made by DES in early December.

Administrative Services

Staffing

A detailed business case was submitted to DES for additional administrative posts and revisions were subsequently requested to the proposal. I have requested a meeting to discuss the matter further and await a response to same.

Capital

Work commenced on the new school building at Tullamore College on 1 September and progress to date is to schedule.

A number of our schools received funding for minor upgrades through the Summer Works Scheme and Emergency Works Scheme.

Additional temporary accommodation was approved for Oaklands Community College and all works are now complete. We await a response from DES on the proposed redevelopment of the site.

9. PROPOSAL TO BORROW BY WAY OF OVERDRAFT FACILITY:

Following a proposal approved at the September meeting of Laois and Offaly ETB that the Board should borrow money for the purposes of carrying out the Board's function and the subsequent consent received from the Minister of Education and Skills, the following resolution was accepted by members:

Resolution regarding Bank Overdraft Facility

That the Board, on the consent of The Minister for Education and Skills dated 6th October 2014, accepts the Chief Executives proposal to accept the offer of the facility mounting to EUR 3,300,000 made by Allied Irish Banks, p.l.c. ("the Bank") to the Laois and Offaly Education and Training Board subject to the terms and conditions referred to in the letter of sanction dated 3rd November 2014 addressed by the Bank to the Board, and that Denis Magner and Joe Cunningham (Chairperson and Secretary) are hereby authorised to sign on behalf of the Board the letter of sanction and such other authorities, documents and instructions that the Bank shall require to be signed by the Board in connection with the facility.
